Flooding Issues: Many residents came to the Council Meeting, Amy Kreider and Robert Rehrer addressed Council about their concerns regarding their water and sewer issues. Mike Setley addressed the residents and Council on behalf of Wernersville Municipal Authority and its efforts to respond to the issue. Jared Renshaw, Chief of Western Berks Fire Department also addressed the residents and Council about efforts provided by the Fire Department to assist residents impacted by the flooding. Council advised the residents in attendance that we will be working with the Wernersville Municipal Authority and Great Valley Consultants to develop a plan to address the issues.

<u>Wernersville Public Library</u>: Leigh-Anne Yacovelli, Library Director reported that their Summer Reading Program was a huge success. She also, thanked Borough Council for all their support.

<u>11 South Pearl Street</u>: Bonnie Bollinger, 11 S. Pearl Street, asked Council who owns the alley behind her home. Council directed the Borough Solicitor, Michael Gombar, Jr. to look into this and get back to her with an answer.

<u>Diakon Lutheran:</u> Peter Edelman, Esquire reported to Council about the Project. Motion made by B. Clements to adopt a Resolution for Tax Free Financing for Diakon Lutheran and Wernersville Municipal Authority. J. Swartz seconded and carried unanimously.

<u>Bachman's Roofing 36 S. Elm St.:</u> Brad Boltz reported to Council about the Project. On the recommendation of the Planning Commission, motion made by D. Latino to grant the Waiver of Land Development for Bachman's Roofing at 36 S. Elm St. for a 5,000 square foot addition subject to Bachman agreeing to pay all Borough engineering, legal and administrative fees, securing a building permit, complying with all zoning ordinance requirements and submitting the storm drainage design to the Borough for review.
