STORMWATER MANAGEMENT/MS4

Why Do We Regulate Stormwater?

The MS4 program requires the MS4 owner/operator to implement a series of programs to reduce the discharge of pollutants from the storm sewer system to the maximum extent practicable in a manner that protects water quality. The Pennsylvania Code Chapter 93 sets the water quality standards for surface waters of the Commonwealth and these standards seek to protect the waters for aquatic life, water supply, recreation and fish consumption, and areas that need special protection. The MS4 program focuses on managing discharges into the waters of the Commonwealth by educating and implementing proper control measures and best management practices (BMPs).

One of the control Measures for MS4 is Illicit Discharge Detection & Elimination

Why are illicit (illegal) discharges important?

Illicit discharges make their way to our waterways untreated. Illicit discharges such as paint or oil dumped into storm drains, septic effluent, car wash wastewater, and illegally connected wastewater piping into sewers can cause serious pollution issues. These illicit discharges can carry a variety of pollutants, such as heavy metals, bacteria, viruses, nutrients, oil and grease, and solvents.

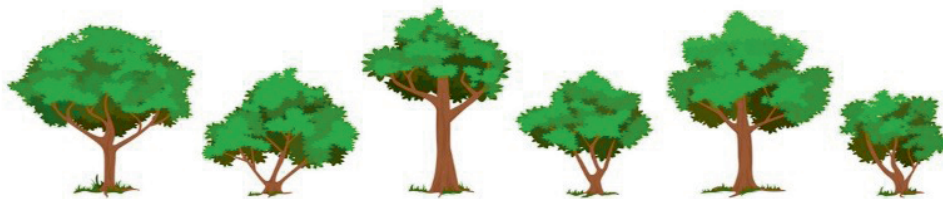
Illicit discharges are dangerous to public and environmental health, it's unsightly, may affect drinking water, and will diminish recreational value.

IMPORTANT INFORMATION FOR HOME OWNERS:

Home Addresses: all home addresses should be easily visible from the street in case of emergency.

Selling your home? The Wernersville Borough requires an inspection prior to making settlement on the sale of a home in the Borough, under Ordinance 545. Please contact us for the form and fee for this inspection. All homes must also have Sidewalk and Curbing, under Ordinance 530. If they do not have sidewalk and curb prior to the sale, it would need to be installed by the new buyer within 120 days after settlement.





Keep Trees Trimmed

Please keep trees in your front yard and in the shade tree space (between the sidewalk and street) trimmed so that they are not hanging down over the sidewalk and street. Trees must be trimmed to no less than 7 feet about sidewalk and no less than 15 feet above the street. Please make sure that you are keeping your sidewalks clear of any tree limbs, bushes, brush, debris and weeds etc. so that they are safe for pedestrians. If you have any bushes or trees close to the sidewalk, please make sure they are trimmed.

WEEDS: Please make sure you keep your sidewalks and curbs weed free. It is the responsibility of the resident/homeowner to maintain the sidewalk and pull or spray weeds along the curb.

Yard waste can be taken to South Heidelberg drop off. The gates are open 7AM-8PM (April 1 through October 31) and 7AM-6PM (November 1 through March 31).

Directions: go past the Moyer Nissan building, take the first left onto Point Road.

Drop-off is to the right. ****Please Note: will need an access card to use the Yard Waste Drop off Site****

Keep tree limbs, trash cans and cars off of the sidewalk and curb

DO NOT blow cut grass out into the street. It is a safety hazard and harmful to the environment.

Curbside Yard Waste Collection will be on Monday, June 17th. **YOU MUST** call the Borough office at 610-678-1486 to **SCHEDULE** your pick-up by June 14th. Place items out the night before, we will be picking up early. Yard waste (limbs, branches, shrub trimmings, etc.) should be tied and properly bundled, maximum size 48"X18"X18" will be collected. Trimmings should be properly tied or placed in an open container. **NO TRIMMINGS IN PLASTIC BAGS AND ABSOLUTELY NO GRASS WILL BE COLLECTED.**

ORDINANCES TO KNOW

DOG ORDINANCE- An ordinance is enforced in the Borough that dogs must be on a leash, muzzle, and/or similar restraining device; or in an enclosure from which they cannot escape. Also, dogs are NOT allowed in any of the Borough Parks.

ANIMAL WASTE ORDINANCE- Animal owners must clean up animal waste and dispose of properly in a sealed bag or container and deposit in trash receptacle.

DOG LICENSES- All dogs in Berks County must have a license. To obtain a license contact the County of Berks.

WEED REMOVAL ORDINANCE- Requires all grass, weeds, and other vegetation, in excess of 6 inches to be cut. The owner of any rental or vacant property shall carry out the same requirements.

PORTABLE BASKETBALL NET ORDINANCE- These are not allowed to be placed on the planting strip overhanging into the street or placed in the street.

FIRE PITS/OPEN BURNING- Fire pits are permissible if they are being used for cooking food. No Open burning of items such as furniture, recyclables, or yard waste, etc. is permitted.

TRAILERS- No Trailer, whether attached to or not attached to a vehicle, shall be parked, or stored on any Borough Street for a continuous period exceeding 24 hours.

COMMERCIAL VEHICLES- No commercial vehicle with a Gross weight of 10,000 pounds or more shall be parked on a Borough street for more than one (1) hour. This includes Tow Trucks, car carriers and low boy trailers.

IMPORTANT THINGS TO REMEMBER

- **Trash Day** is on **EVERY WEDNESDAY Morning!** If a holiday falls on or before a trash day, pick-up will be the following day. The affected Holidays will be Memorial Day (5/27), 4th of July, and Labor Day (9/2). Due to these holidays, Trash will be picked up on Thursdays during those weeks.
- **Recycling Day** is on **EVERY THURSDAY Morning!** Recycling will be collected on Friday if a Holiday falls in that week. Due to Memorial Day, 4th of July and Labor Day, Recycling will be picked up on Fridays during those weeks.
- **Election Day** is April 23rd at the Borough Hall
- **Street Sweeping** will occur the week of April 29th to May 3rd , Weather Permitting. Please watch for signs.
- **Wernersville Annual Yard Sale:** will be Saturday May 11th and Sunday May 12th.
- **Memorial Day Parade:** Monday, May 27th at 10am (starting and ending at the Western Berks Fire Department).
- **Flag Day Ceremony:** @ the Heidelberg Heritage Society Lerch Tavern, Wednesday, June 14th at 7pm. Bring your old flags and lawn chairs if needed.

**Please make sure that you are placing your trash and recycling bins in the planting strip, not in the street or gutter. Thank you. **

Recycling bins (black with yellow lids) are to be used for Recycling ONLY. Do not place trash in these bins

REMINDER: please put trash and recycling bins out the night before they are to be collected.

KEEP RECYCLING SUCCESSFUL-SINGLE STREAM RECYCLING

Acceptable items:

- White envelopes, junk mail
- Computer, fax, notebook and copy paper
- Kraft paper/brown grocery bags
- Magazines, catalogs, phone books and paperback books
- Chipboard/boxboard
- White and colored ledger paper, construction paper
- Newspaper
- Paper egg cartons
- Juice boxes, milk cartons and frozen food cartons
- Aluminum cans
- Tin and Bi-metal containers (including aerosol cans)
- Aluminum foil (pie plates, etc)
- Plastic containers 1-7

Unacceptable items:

- Trash
- Clothing
- Diapers
- **Styrofoam/styrofoam peanuts**
- Bags
- Caps/Lids
- Food
- Yard Waste
- Mirrors, window glass, light bulbs
- Paper towels
- Propane tanks
- Medical waste

REMINDER: NO PLASTIC BAGS.

****Please Note:** If any of these items are put out with your recycling, the hauler will not take your recycling.

LIQUIDS must be emptied from bottles and cans before they are placed into the recycling bin.

WHO MUST COMPLY? All Businesses and residents in the Borough must comply. Each calendar year, Businesses and residential properties not included in the Borough's collection program, are required to report how much you recycle and where the materials were marketed.



Trash Collection pick-up is every Wednesday. If a Holiday is on a weekday and falls on a weekday (M-F) on or before Trash and/or recycling pick up, pick-up will be the following day. The holidays that may affect trash pick-up are Memorial Day, July 4th, Labor Day, Thanksgiving, Christmas Day, and New Year's Day.

Four (4) Bags/Containers per home.

If you have a large bulk item, you must CALL Waste Management at 610-440-3700 and give the account # 603-6589 to schedule a bulk item pick up, at an additional charge.

Please be sure to BAG cat litter and dog/animal waste before placing it in your container.

Recycling Collection pick-up is every Thursday. Recycling will be collected on Friday if a Holiday falls in that week. Due to Memorial Day, 4th of July and Labor Day, Recycling will be picked up on Fridays during those weeks.

Please remember there is NO glass in recycling and NO plastic bags. Recyclable materials should be rinsed out before being placed in bins.

The recycling bin provided by Waste Management is ONLY for recycling. If trash is placed in the recycling bin, it will not be picked up.

Electronic Waste Collection: The Solid Waste Authority has an electronic-waste collection center located at 1316 Hilltop Rd., Leesport. The center is open Tuesday, Thursday, and Saturday from 8AM to 12 noon. They accept all electronic items, TV (limit 2), VCR, microwave, air conditioners, and fluorescent light bulbs, etc. This is free for all residents. There is a fee for businesses and an appointment is needed. Call 610-478-6362 if you need more information.

From the Codes Department

Just a friendly reminder ...

All fences, sheds, decks, patios and the like require, at a minimum, a zoning permit prior to construction or installation.

Also, as the warmer weather approaches, you may think about relief from the heat in the form of a swimming pool. Please be aware, that all swimming pools, whether in-ground, temporary or permanent, that are designed to hold 24 inches or more of water must comply with zoning and building codes. All swimming pools that are designed to hold 24 inches or more of water have specific electrical and barrier (safety) requirements through the state building code. A zoning and building permit is required prior to the installation and use of those swimming pools holding 24 or more inches of water.

Additionally, the Borough enforces the 2006 International Property Maintenance Code as the regulation for the maintenance of properties and building within the Borough. This code includes but is not limited to, the maintenance of buildings such as peeling paint, structural members, roofing materials etc. The code also regulates the appearance of properties related to the outdoor storage of materials or debris that are not designed to be stored outside. This includes rubbish, garbage, and cars in disrepair on the property that are not registered, inspected or licensed.

Grass and weeds must be trimmed to less than 6 inches high.

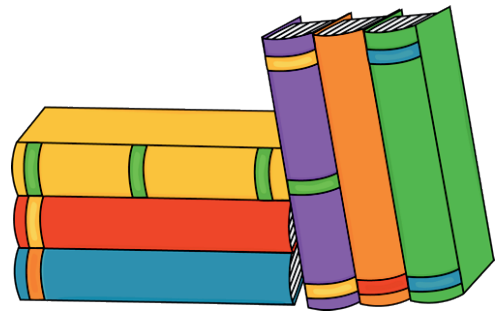
Also, it is the responsibility of the homeowner to fix their sidewalks or curbs if they are in disrepair.



Please be advised that the Borough may begin actively patrolling for property maintenance violations. If you see something that may be in violation of the property maintenance code, feel free to file a complaint with the Borough Office by calling us at 610-678-1486.

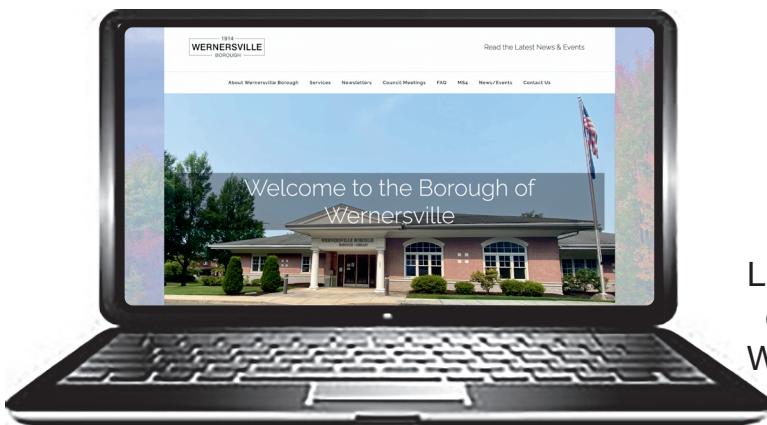
