### **Council's Report:**

**Linda Dapcic-Angst:** Do we want to take action on a No Plastic Bag Ordinance? Linda discussed the plastic bag Ordinance with Council. Council decided to take no action at this time.

Linda also discussed an LSA Grant that is due by November 30, for up to 1 Million Dollars. She requested that any ideas for the grant be sent to her by the Budget meeting on Monday, October 13. This will be put on the November Agenda as an action item to authorize Linda to apply for the Grant.

This will be added to the Agenda for the Budget meeting on October 13, 2025. Keegan will write the letter of support for Council to approve.
